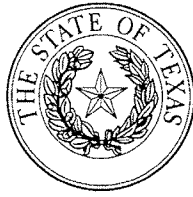

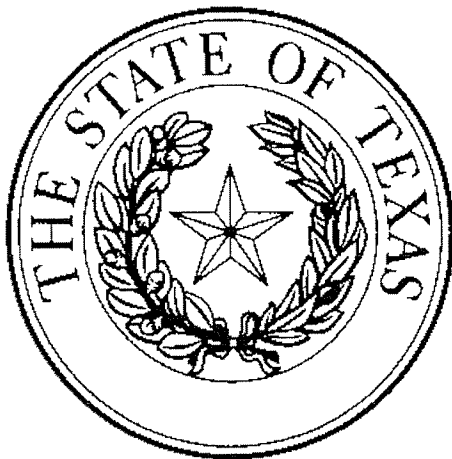

Pursuant to the provision of Article 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following articles of amendment to its Fourth Restated Articles of Incorporation:

**ARTICLE ONE**

The name of the corporation is as set forth below:
