**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of April 7, 2006, is made by Bank of America, N.A. as successor by merger to Fleet National Bank ("Agent") in favor of Peter Piper, Inc. (the "Borrower").

WHEREAS, the Borrower has requested that Agent release its security interest in the collateral described in the aforementioned Trademark Security Agreement and License (the "Collateral").

NOW, THEREFORE, Agent hereby **RELEASES** all of its security interest in the Collateral, namely, the trademarks listed in Schedule A and the trademark registrations listed in Schedule B, both schedules attached hereto and incorporated herein by reference, and any other collateral described in the aforementioned Trademark Security Agreement and License.






Agent agrees, at the Borrower's expense, to cooperate with the Borrower and to provide the Borrower with the information and additional authorization necessary to effect the release of Agent's security interest in the Collateral.
