**RELEASE OF SECURITY INTEREST**  
**IN TRADEMARK COLLATERAL**

This RELEASE, dated as of April 7, 2006, is made by Bank of America, N.A. as successor by merger to Fleet National Bank ("Agent") in favor of Pistol Pete's Pizza, Inc. (the "Company").

W I T N E S S E T H:

WHEREAS, Agent was involved in a credit facility pursuant to which credit was extended to the Peter Piper, Inc., and in return the Company granted security interests pursuant to the following:

A Subsidiary Trademark Security Agreement and License dated April 26, 2000, between Agent and the Company, recorded with the U.S. Patent and Trademark Office on May 9, 2000, Reel/Frame 002077/0656 (as amended, the "Subsidiary Trademark Security Agreement and License").

WHEREAS, Agent acknowledges full payment, performance and satisfaction of all obligations secured by the above-referenced Subsidiary Trademark Security Agreement and License; and

WHEREAS, the Company has requested that Agent release its security interest in the collateral described in the aforementioned Subsidiary Trademark Security Agreement and License (the "Collateral").

NOW, THEREFORE, Agent hereby **RELEASES** all of its security interest in the Collateral, namely, the trademarks listed in Schedule A and the trademark registrations listed in Schedule B, both schedules attached hereto and incorporated herein by reference, and any other collateral described in the aforementioned Subsidiary Trademark Security Agreement and License.

Agent agrees, at the Company's expense, to cooperate with the Company and to provide the Company with the information and additional authorization necessary to effect the release of Agent's security interest in the Collateral.
