ASSIGNMENT FOR SECURITY  
TRADEMARKS

WHEREAS, Global Employment Solutions, Inc., a Colorado corporation (the "Assignor"), has adopted, used and is using, and holds all right, title and interest in and to, the service marks listed on the annexed Schedule 1A, which service marks are registered or applied for in the United States Patent and Trademark Office (the "Trademarks");

WHEREAS, the Assignor has entered into a Security Agreement, dated as of March 31, 2006 (as amended, restated or otherwise modified from time to time the "Security Agreement"), in favor of Amatis Limited, as collateral agent for certain purchasers (the "Old Assignee");

WHEREAS, the Old Assignee has requested to be relieved of its role as collateral agent and Whitebox Convertible Arbitrage Partners, LP has agreed to become the replacement collateral agent (the "New Assignee");

WHEREAS, pursuant to the Security Agreement, the Assignor has assigned to the New Assignee, and granted to the New Assignee for the benefit of the Buyers (as defined in the Security Agreement), a continuing security interest in all right, title and interest of the Assignor in, to and under the Trademarks, together with, among other things, the good-will of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the "Collateral"), to secure the payment, performance and observance of the "Obligations" (as defined in the Security Agreement);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor does hereby pledge, convey, sell, assign, transfer and set over unto the New Assignee and grants to the New Assignee for the benefit of the Buyers a continuing security interest in the Collateral to secure the prompt payment, performance and for the benefit of the Buyers observance of the Obligations.

The Assignor does hereby further acknowledge and affirm that the rights and remedies of the New Assignee with respect to the Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.
