## TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "*Assignment*"), dated as of January 12, 2007, is made by IMPERIAL BAG & PAPER CO., INC., a New Jersey corporation ("*Assignor*"), in favor of IMPERIAL BAG & PAPER CO. LLC, a Delaware limited liability company (the "*Assignee*").

**WHEREAS**, Assignor is the sole and exclusive owner of all right, title and interest in and to that trademark as set forth on the attached Schedule A and all goodwill associated therewith (collectively, the "*Mark*"). Pursuant to that certain Asset Purchase Agreement, dated as of December 13, 2006, Assignor sold to Assignee its right, title and interest to, among other things, the Mark.

**NOW, THEREFORE**, for good and valuable consideration paid by Assignee, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby irrevocably assigns to Assignee, its successors and assigns, all of its right, title and interest in and to the Mark together with the goodwill of the business in connection with which the Mark is used, and all registrations and trademark applications therefore, in the United States, its territories and possessions and throughout the world as well as renewals and extensions of the registrations that are or may be secured under the laws of the United States, its territories and possessions and throughout the world.

Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States of America, or with respect to any foreign trademarks or service marks or applications or registrations for such marks the foreign equivalent as the case may be, to record Assignee as owner of the Mark and to issue any and all registrations, including renewals thereof, to Assignee, its successors, assigns, nominees or other legal representatives. Assignor hereby represents and covenants that it has the full right to convey the entire interest herein assigned, and that it has not executed and will not execute any agreement in conflict with this Assignment.
