THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is made as of July 28, 2006 ("Effective Date") by and among **Credit Suisse, Cayman Islands Branch**, as Collateral Agent, as defined in the Credit Agreement and/or Guarantee and Collateral Agreement, with an address at Eleven Madison Avenue, New York, New York 10010, USA ("Grantee"), **Magellan Holdings, Inc.**, a Georgia corporation ("Magellan"), **Infor Global Solutions Technology GmbH** ("Swiss IPco"), each of the parties identified on Schedule I attached hereto as "**Luxembourg Obligations Grantors**" (the "Lux Obligations Grantors"), and each of the parties identified on Schedule I attached hereto as "**All Obligations Grantors**" (the "All Obligations Grantors" and together with Magellan, Swiss IPco, and the Lux Obligations Grantors, the "Grantors").

WHEREAS, pursuant to the terms and conditions of that certain Amended and Restated Second Lien Credit Agreement dated as of March 14, 2006 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement") among Infor Global Solutions AG, Infor Global Solutions Technology GmbH, Infor Swiss Holdings GmbH, Magellan Holdings, Inc., and Infor Global Solutions European Finance, S.a.R.L., the Lenders parties thereto, J.P. Morgan Securities Inc. and Credit Suisse Securities (USA) LLC, as Co-Lead Arrangers, JPMorgan Chase Bank, N.A., as Syndication Agent, the Collateral Agent and Grantee, as Administrative Agent, Grantors executed and delivered to the Administrative Agent an Amended and Restated Second Lien Guarantee and Collateral Agreement in favor of the Collateral Agent (the "Guarantee and Collateral Agreement");

WHEREAS, pursuant to the Guarantee and Collateral Agreement, Grantors executed and delivered that certain Short Form Second Lien Trademark Security Agreement by and among Magellan, the Lux Obligations Grantors, the All Obligations Grantors, and Grantee dated as of March 14, 2006 (the "Trademark Security Agreement"), and that certain Short Form Second Lien Copyright Security Agreement by and among Magellan, the Lux Obligations Grantors, the All Obligations Grantors, and Grantee dated as of March 14, 2006 (the "Copyright Security Agreement");

WHEREAS, pursuant to the Guarantee and Collateral Agreement, Swiss IPco executed and delivered that certain Second Lien Patent Security Agreement between Swiss IPco and Grantee, dated as of March 14, 2006 (the "Patent Security Agreement" and, together with the Credit Agreement, the Guarantee and Collateral Agreement, the Trademark Security Agreement, and the Copyright Security Agreement, the "Security Agreements");

WHEREAS, pursuant to the Security Agreements, each Grantor granted to Grantee a continuing security interest in and to all of such Grantor's right, title and interest in and to the collateral, including, without limitation, the United States and foreign trademark registrations and applications, together with the goodwill associated therewith, the patents and patent applications, and the copyright registrations set forth on Schedule A attached hereto, and all products and proceeds thereof (collectively, the "Scheduled Intellectual Property");


