This Certificate of Conversion to Limited Liability Company, dated as of December 28, 2006, has been duly executed and is being filed by Valley-Dynamo, L.P., a Delaware limited partnership (the "Partnership"), to convert the Partnership to a Delaware limited liability company, under the Delaware Limited Liability Company Act (6 Del.C. § 18-101, et seq.) and the Delaware Revised Uniform Limited Partnership Act (6 Del.C. § 17-101, et seq.).

1. The Partnership's name when it was originally formed was BBB Acquisition, LP and, subsequently, immediately prior to the filing of this Certificate of Conversion to Limited Liability Company, was Valley-Dynamo, L.P.
