U.S. TRADEMARKS RELEASE OF SECURITY INTEREST

THIS RELEASE dated as of July 14, 2006 by CREDIT SUISSE (formerly known as Credit Suisse First Boston), as collateral agent (in such capacity, the "*Collateral Agent*") for the Secured Parties. Terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Existing Credit Agreement referred to below.

A. Reference is made to the Amended and Restated Credit Agreement dated as of July 3, 2002 (as amended, supplemented or otherwise modified prior to the date hereof, the "*Existing Credit Agreement*"), among Terex Corporation ("*Terex*"), New Terex Holdings UK Limited, Terex International Financial Services Company, Powerscreen International Limited, P.P.M. S.A.S., Terex Mining Australia Pty Ltd, Terex Germany GmbH & Co. KG and Terex Italia S.R.L., the lenders from time to time party thereto (the "*Lenders*") and Credit Suisse, Cayman Islands Branch (formerly known as Credit Suisse First Boston) as Collateral Agent.

B. Reference is made to the Security Agreement dated as of March 6, 1998 (as amended, supplemented or otherwise modified from time to time, the "*Security Agreement*"), among Terex, the subsidiaries of Terex party thereto (together with Terex, the "*Grantors*") and the Collateral Agent. Pursuant to the Security Agreement, the Grantors granted a security interest to the Collateral Agent, for the benefit of the Secured Parties, in, among other things, the registered trademarks and trademark applications of the Grantors set forth on Schedule I hereto (the "*Trademarks*"), which security interest was recorded with the United States Patent & Trademark Office.

C. In connection with the termination of the Existing Credit Agreement, the Grantors have informed the Collateral Agent of their desire to obtain the release of all right, title and interest of the Secured Parties and each other grantee or beneficiary in and to the Trademarks granted under the Security Agreement and the other Loan Documents.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, all the Collateral Agent's right, title and interest (including, without limitation, security interests) in and to the Trademarks pursuant to the Security Agreement and the other Loan Documents shall hereby automatically terminate (without any representation or warranty of any kind or nature), including, without limitation, the Trademarks set forth on Schedule I attached hereto, the debt secured thereby having been paid and satisfied in full.


