

RELEASE OF  
SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL

WHEREAS, pursuant to that certain Revolving Credit, Term Loan and Security Agreement dated as of March 8, 2004 (as amended to date, the "Loan Agreement"), by and among Elgar Holdings, Inc., a Delaware corporation, Elgar Electronics Corporation, a California corporation (the "Assignor"), in favor of CapitalSource Finance LLC, as administrative, payment and collateral agent for the Lenders under the Loan Agreement (the "Assignee"), Assignor granted a security interest in, among other collateral, certain intellectual property of Assignor to Assignee for itself and the benefit of the Lenders.

WHEREAS, in conjunction with the Loan Agreement, by an Acknowledgment of Intellectual Property Collateral Lien dated as of March 8, 2004 (as amended to date, the "Acknowledgment"), recorded in the United States Patent and Trademark Office on April 9, 2004 at Reel/Frame 2829/0836 and at Reel/Frame 014506/0488, Assignor assigned to and granted to Assignee, a security interest in all right, title and interest of Assignor in and to the Patents and Trademarks attached hereto as Schedule 1, (the "Intellectual Property Collateral").

WHEREAS, Assignee wishes to provide a document suitable for recording in the United States Patent and Trademark office for purposes of recording the release, relinquishment and discharge of its security interest in the Intellectual Property Collateral.

Capitalized terms used herein and not defined shall have the respective meaning ascribed to such terms in the Loan Agreement or the Acknowledgment as applicable.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Assignee hereby relinquishes, releases and discharges its security interest in the Intellectual Property Collateral and reassigns any and all interest that it may have in the Intellectual Property Collateral to Elgar Electronics Corporation, a Delaware corporation, a successor by merger to a California corporation with the same name, and formerly known as Elgar Holdings, Inc.

IN WITNESS WHEREOF, the Assignee has caused this Release of Security Interest in Intellectual Property Collateral to be duly executed as of December 22, 2006.
