Under Section 905 of the Business Corporation Law

I, the undersigned, being the Secretary of Rhone-Poulenc Ag Company Inc. do hereby certify:

- 1. The name of the corporation is Rhone-Poulenc Ag Company Inc.
- 2. The original certificate of incorporation of the corporation was filed by the Department of State on March 26, 1968 under the name Rhodia Inc.
- 3. The certificate of incorporation is hereby amended to change the corporation's name.

Article I of the certificate of incorporation relating to the corporate name is amended to read as follows:

L. The name of the Corporation is Aventis CropScience USA Inc.

4. This amendment to the certificate of incorporation was authorized by the unanimous written consent of the Board of Directors of the corporation and by written consent of the sole shareholder of the corporation.
