**TERMINATION OF SECURITY INTEREST  
(Trademarks)**

This **TERMINATION OF SECURITY INTEREST**, dated as of December 21, 2006, is made by AMERICAN CAPITAL FINANCIAL SERVICES, INC, as Agent for the Purchasers (the "Agent").
