ASSIGNMENT OF TRADEMARKS

WHEREAS, CBS Radio Stations Inc. 

This Assignment is made without representation or warranty, except as provided in and by the Purchase Agreement. To the extent there is a conflict between the terms and provisions of this Assignment and the terms and provisions of the Purchase Agreement, the terms and provisions of the Purchase Agreement shall govern.


