**CERTIFICATE OF MERGER AND NAME CHANGE
OF

(a Delaware limited partnership)
WITH AND INTO
CNN INVESTMENT COMPANY, INC.
(a Delaware corporation)**

Pursuant to Title 8, Section 263(c) of the Delaware General Corporation Law of the State of Delaware (the "DGCL") and Title 6, Section 17-211 of the Delaware Revised Uniform Limited Partnership Act (the "DRULPA"), CNN Investment Company, Inc. executes the following Certificate of Merger:

1. The name and state of domicile of each of the constituent entities which are to merge are:

Cable News Network LP, LLLP	Delaware
CNN Investment Company, Inc.	Delaware

2. The name of the surviving corporation is CNN Investment Company, Inc., a Delaware corporation, that simultaneously with the merger shall hereby change its name to Cable News Network, Inc.
3. The Agreement of Merger, dated as of December 31, 2006, between Cable News Network LP, LLLP and CNN Investment Company, Inc. has been approved, adopted, certified, executed and acknowledged by each of the constituent entities in accordance with Section 263(c) (and with respect to CNN Investment Company, Inc., Section 228) of the DGCL and Section 17-211 of the DRULPA.
4. The merger shall be effective at 11:58 p.m. EST on December 31, 2006.
5. The executed Agreement of Merger is on file at the principal place of business of CNN Investment Company, Inc. which is located at One CNN Center, Atlanta, Georgia 30303.
6. A copy of the Agreement of Merger will be furnished by CNN Investment Company, Inc. on request and without cost, to any stockholder of CNN Investment Company, Inc. or any partner of Cable News Network LP, LLLP.
7. The Certificate of Incorporation of CNN Investment Company, Inc. shall be the Certificate of Incorporation of the surviving corporation. Such Certificate of Incorporation shall be amended at the time of the merger as follows to reflect the name change to Cable News Network, Inc.:


The first paragraph of the Certificate of Incorporation is deleted in its entirety and replaced with a new first paragraph to read as follows:

"FIRST: The name of the corporation is Cable News Network, Inc. (the "Corporation")."
