TRADEMARK AND TRADE NAME SECURITY AGREEMENT

THIS TRADEMARK AND TRADE NAME SECURITY AGREEMENT ("Agreement") is between Detroit Stoker Company, a Michigan corporation (the "Debtor"), and PNC Bank, National Association, a national banking association, as Agent (as defined herein below) for the Lenders (as defined herein below) (the "Secured Party").

WHEREAS, the Debtor has acquired, adopted and used, or is using, from time to time as required to operate its business, the trademarks, trade names, service marks, brand names, logos and other trade designations, trademark and/or service mark registrations and applications listed in Exhibit A attached hereto and made a part hereof, which, as indicated in Exhibit A, are registered in the United States Patent and Trademark Office.

WHEREAS, the Debtor, DSC Services Inc., the financial institutions party thereto from time to time (collectively, the "Lenders") and the Secured Party, as a Lender and as agent for the Lenders (in such capacity, "Agent"), have concurrently herewith entered into a Revolving Credit and Security Agreement (the "Loan Agreement") pursuant to which the Secured Party has been granted security interests in said trademarks, trade names, service marks, brand names, logos and other trade designations, trademark and/or service mark registrations and applications thereof.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Debtor does hereby grant, transfer, assign and convey pursuant to the terms and conditions of the Loan Agreement and this Agreement a lien and security interest to the Secured Party in all rights, titles and interests of the Debtor in and to the said trademarks, trade names, service marks, brand names, logos and other trade designations, trademark and service mark registrations and applications, together with the goodwill of the business symbolized by such trademarks, trade names, service marks, brand names, logos and other trade designations, trademark and service mark registrations and applications (all such property being referred to collectively herein as the "Trademark Collateral").

The Debtor further covenants and warrants to the Secured Party as follows:

- (a) the Debtor is the owner of the Trademark Collateral and all rights comprised of the Trademark Collateral, subject to limitations imposed by law, and has the full authority to make this assignment;
- (b) none of the Trademark Collateral has heretofore been pledged, hypothecated or otherwise encumbered by Debtor, and to Debtor's knowledge, is in all aspects free and clear of any encumbrances except those arising by statutory law, if any;
- (c) to the Debtor's knowledge the validity of the Trademark Collateral has never been questioned;
- (d) the Debtor has not entered into any contract or made any commitment that will or may impair the Secured Party's rights hereunder; and
- (e) the Trademark Collateral and all rights comprised of the Trademark Collateral shall not be licensed or assigned in any manner without prior permission from the Secured Party.

THIS TRADEMARK AND TRADE NAME SECURITY AGREEMENT HAS BEEN EXECUTED, DELIVERED AND ACCEPTED AT AND SHALL BE DEEMED TO HAVE BEEN MADE AT THE SECURED PARTY'S OFFICES IN DALLAS, TEXAS, AND SHALL BE

INTERPRETED AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HERETO DETERMINED IN ACCORDANCE WITH AND GOVERNED BY APPLICABLE FEDERAL LAW AND THE INTERNAL LAWS OF THE STATE OF TEXAS APPLICABLE TO AGREEMENTS EXECUTED, DELIVERED AND PERFORMED THEREIN.

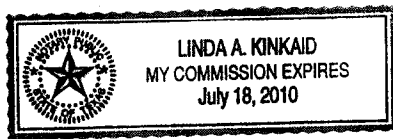
