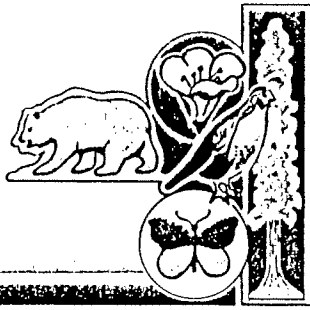

CERTIFICATE OF AMENDMENT OF ARTICLES OF INCORPORATION OF
KEEPERS INDUSTRIES INC.

The undersigned, SIDNEY S. LEVINE and RICHARD J. GREENBERG, hereby do certify that they now are, and during all of the times mentioned herein have been, the President and Secretary respectively of KEEPERS INDUSTRIES INC., a California corporation, and further they do hereby certify as follows:

1. That at a special meeting of the Board of Directors of said corporation held at the office of the corporation at 20720 Marilla Street, Chatsworth, California on March 15, 1993 at 4:00 o'clock p.m., the said Board duly adopted the following resolution:

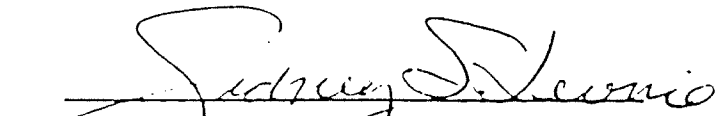
"RESOLVED: that Article FIRST of the Articles of Incorporation of this corporation be deleted in its entirety and that said Article be amended to read in full as follows:


'FIRST: That the name of this corporation is:
KEEPERS INTERNATIONAL'"

2. That at a special meeting of the stockholders of said corporation held at said corporate office on said date at 4:15 o'clock p.m. , the foregoing Amendment to the Articles of Incorporation was adopted, ratified and approved in form identical to the aforesaid resolution of the Board of Directors.

3. That the number of shares voting in favor of the resolution was 144,500 and the number of sahres entitled to vote on or consent to the Amendment is 144,500.
