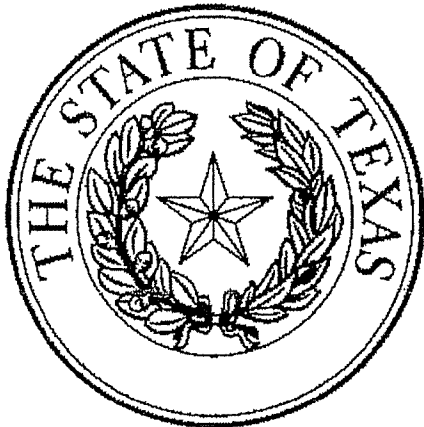

ARTICLES OF AMENDMENT
OF
STATE STREET REFRIG., INC.

The undersigned officer of the filing entity, having been authorized to act on behalf of the filing entity, does hereby file the following articles of amendment to the articles of incorporation of the filing entity.

1. **Entity Information.** The name of the filing entity is State Street Refrig. Inc. The filing entity is a for-profit corporation. The file number issued to the filing entity by the secretary of state is 01050795. The date of formation of the entity is December 28, 1987.

2. **Amendments.**

A. **Amended Name.** This amendment changes the articles of incorporation of the filing entity to change the article that names the filing entity. ARTICLE I of the articles of incorporation of the filing entity is amended to read as follows:

ARTICLE I

The name of the corporation is **CREST FRUIT, INC.**

B **Amended Registered Agent and Registered Office.** This amendment changes the articles of incorporation to change the article stating the name of the registered agent and the registered office of the filing entity. ARTICLE VI of the articles of incorporation of the filing entity is amended to read as follows:

ARTICLE VI

The registered agent is an individual resident of the state whose name is: James Michael Martin. The business address of the registered agent and the registered office address is: 4012 E. Goodwin Road, Mission, Texas 78574.

3. **Statement of Approval.** The amendments to the articles of incorporation included herein have been approved in the manner required by the Texas Business Corporation Act and the constituent documents of the filing entity.

4. **Effectiveness of Filing.** This document becomes effective when the document is filed by the secretary of state.
