ASSIGNMENT OF TRADEMARK

WHEREAS, **Arr-Maz Products, L.P.**, a Delaware Limited Partnership, having a business address of 4800 STATE ROAD E, MULBERRY, FL 33860 (hereinafter referred to as ASSIGNOR) was the beneficial owner of the trademark registration ROAD OYL, filed November 9, 2000, having U. ALL OF THE SAME to be held and enjoyed by said ASSIGNEE for its own use and behoof and for its successors, assigns and legal representatives as fully and entirely as the same would have been held and enjoyed by said ASSIGNOR had this Assignment not been made.

THIS ASSIGNMENT OF TRADEMARK shall be deemed to be effective as of August 31, 2005.
