**RELEASE OF  
GRANT OF SECURITY INTEREST  
IN TRADEMARKS**

WHEREAS, in order to secure certain indebtedness, the Pledgors entered into the U.S. Security Agreement or the Canadian Security Agreement (as amended, modified, restated or supplemented from time to time, the "Security Agreements"), each dated as of June 4, 2004, in favor of Royal Bank of Canada, as Collateral Agent (the "Collateral Agent") to execute and deliver a Trademark Security Agreement (the "Trademark Agreement") as recorded in the United States Patent and Trademark Office at Reel 3011, Frame 0086 on July 16, 2004, and Reel 3024, Frame 0358 on July 16, 2004 pursuant to which Pledgors granted to the Collateral Agent, according to the terms of the Security Agreements, a security interest in all of its right, title and interest in and to the Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent does hereby release and relinquish, and does hereby reassign to the Pledgors, without representation or warranty, all of the Collateral Agent's right, title and interest in and to the Trademarks, and the use thereof, together with all proceeds and products thereof and the goodwill of the businesses symbolized by the Trademarks, and does hereby agree that the filing of the Trademark Security Interest in the United States Patent and Trademark Office as aforesaid may be removed of record.
