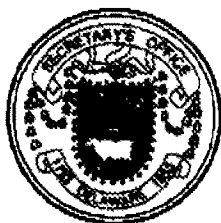

**CERTIFICATE OF AMENDMENT OF  
THE AMENDED AND RESTATED CERTIFICATE OF INCORPORATION OF  
METAVIZE, INC.**

Metavize, Inc., a corporation organized and existing under the General Corporation Law of the State of Delaware, does hereby certify:

**FIRST:** The original name of this company is Metavize, Inc. (the "Company") and the date of filing the original Certificate of Incorporation of this company with the Secretary of State of the State of Delaware was May 27, 2003.

**SECOND:** The Board of Directors of the Company, acting in accordance with the provisions of Sections 141 and 242 of the General Corporation Law of the State of Delaware, adopted resolutions amending its Amended and Restated Certificate of Incorporation as follows:

1. Article I shall be amended and restated to read in its entirety as follows:

"The name of this company is Untangle Networks, Inc. (the "Company")."

2. Article IV., Section D.1.(c) shall be amended to include subsection (iv) which shall read as follows:

"(iv) acquisitions of Common Stock approved unanimously by the Company's Board of Directors"

**FOURTH:** All other provisions of the Amended and Restated Certificate of Incorporation, as currently on file with the Secretary of State of the State of Delaware, shall remain in full force and effect.

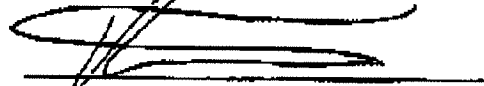
