**ASSIGNMENT OF TRADEMARK**

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by Assignor, Assignor hereby irrevocably assigns and transfers to Assignee all of Assignor's right, title, and interest in and to the SKULL AND BONES DESIGN MARK, and the goodwill of the business associated therewith. This assignment does not include choses in action accruing prior to the date hereof.

Assignor hereby covenants and agrees that he will execute and deliver to Assignee such additional documents, and perform such further acts, as are necessary to enable Assignee to record the assignment of the mark or otherwise to perfect or confirm this assignment and Assignee's rights in the assigned mark.


