## ASSIGNMENT AND CONTRIBUTION AGREEMENT

This Assignment and Contribution Agreement (the "Agreement"), dated December 29, 2005, by and among Library Video Company, a Pennsylvania corporation ("Library Video" or "Assignee"), Andrew Schlessinger, a resident of Pennsylvania and the sole shareholder of Library Video ("Schlessinger" or "Assignor") and Safari Video Networks, LLC, a Pennsylvania limited liability company ("Safari" and collectively with Library Video and Schlessinger, the "Parties"). Library Video and Schlessinger are the only admitted members of Safari.

As of the date hereof, and for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby transfer, assign and set over unto Assignee, as a contribution to the capital of Assignee, to have and to hold forever, all of the Assignor's right, title and interest in and to the membership interest of Safari, being a 1% Percentage Interest (as defined in the Operating Agreement defined below), free and clear of all liabilities. Assignee hereby accepts the assignment and contribution and Safari hereby consents to the assignment of its membership interest.

Neither the making nor the acceptance of this Agreement shall restrict, impair, reduce or, except as set forth below, modify the terms of that certain Limited Liability Company Operating Agreement dated as of January 28, 2005 (the "Operating Agreement") among the Parties. The Parties acknowledge that Exhibit A to the Operating Agreement will be amended to reflect that Assignee holds a 100% Percentage Interest in Safari.

This Agreement is binding on Schlessinger, and his successors and assigns, and will inure to the benefit of Library Video, its successors and assigns, and shall be construed and enforced in accordance with the laws of the Commonwealth of Pennsylvania without regard to the conflict or choice of law rules of Pennsylvania or any other jurisdiction.


