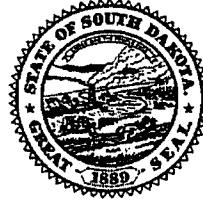

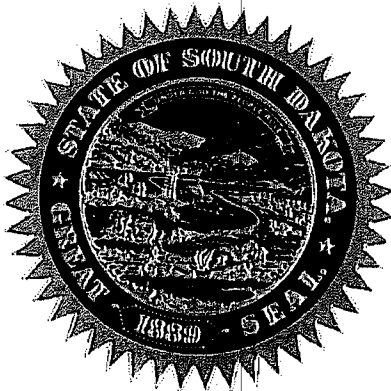

1. The name of the corporation is WESTFIELD DISTRIBUTING (SOUTH DAKOTA) INC.

2. The following amendment of the Articles of Incorporation was adopted by the directors and shareholders of the corporation on December 28, 2006, in the manner prescribed by the South Dakota Business Corporation Act:

The number of shares the corporation is authorized to issue is: 100,000 shares of common stock, par value \$1.00 per share.

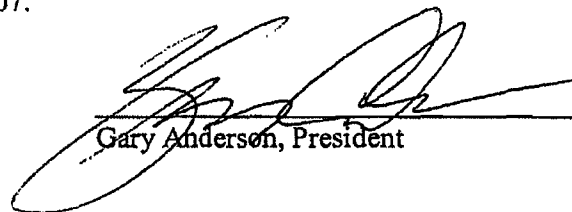
