(Trademarks)

This RELEASE OF SECURITY INTEREST (Trademarks) (this "Release") is made and effective as of the 17th day of JANUARY 2007 (the "Effective Date") and is granted by **REGIONS BANK** ("Regions Bank"), in favor of **DATA RESEARCH ASSOCIATES, INC.** (the "Releasee").


