TRADEMARK ASSIGNMENT

The parties, therefore, agree as follows:

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby transfers, assigns, and otherwise conveys to Assignee, its successors and assigns, all of Assignor's right, title, and interest in, to, and under the following:

1. The Marks;
2. The goodwill associated with the Marks; and
3. All income, royalties, payments due or payable to Assignor, or rights to damages for the Marks or the goodwill associated with the Marks as of the effective date of this Agreement or thereafter, including, without limitation, any and all claims for damages by reason of past, present, or future infringement or other unauthorized use of the Marks, with the right to sue for and collect the same for Assignee's own use and benefit and for the use and enjoyment of its successors and assigns.
