NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby assign, transfer and otherwise convey to Assignee, all of Assignor's right, title and interest worldwide in and to the Trademarks, including all of its common law rights therein, applications to register and registrations therefor, together with the goodwill of the business in connection with which the Trademarks are used or are proposed to be used and further including all claims for damages by reason of past infringement of the Trademarks with the right to sue for and collect the same for Assignee's own use and benefit.

Assignor does hereby expressly agree that it shall provide such assistance and do all things as may be reasonably required to execute the transfer of the Trademarks to Assignee pursuant to the procedures selected by Assignee.

Assignor represents that Assignor has the rights, titles, and interests to convey as set forth herein, and covenants with Assignee that the Assignor has made or will make hereafter no assignment, grant, mortgage, license, or other agreement affecting the rights, titles, and interests herein conveyed.
