## ASSIGNMENT

THIS ASSIGNMENT is made effective as of the 18<sup>th</sup> day of March, 2003, from **Harry Palermo and Ray Domecq** of Teton County, Wyoming (collectively, the "Assignor"), to **Wyoming West Designs II, Inc.**, a Wyoming corporation (the "Assignee"), with its principal office located in Teton County, Wyoming.

### Recitals:

The Assignor owns the membership interests in **Wyoming West Designs LLC**, a Wyoming limited liability company, and wishes to transfer said membership interests to the Assignee as consideration for the issuance of shares of its capital stock to Assignor.

NOW, THEREFORE, it is agreed that:

1. Transfer. Assignors each hereby contributes, transfers and assigns, effective as of the date hereof, Assignor's entire right, title, and interest in said membership interests.
2. Exchange of Stock. The Assignee shall issue to Assignor a total of two thousand shares of its no par value common stock, in equal shares, as soon as practicable after the execution of this Assignment.
3. Tax-Free Exchange. The assignment and issuance of shares of capital stock under this agreement are intended to be a tax-free exchange under Section 351 of the Internal Revenue Code.
4. Conduct of Business. Said business shall hereafter be conducted by the Assignee, and each Assignor shall be involved solely as an officer, director or employee of the Assignee.


