
ASSIGNMENT



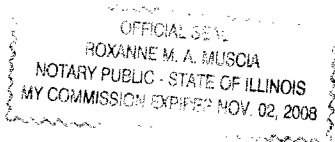
