

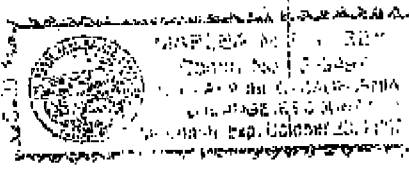

DECLARATION TO RERECORD ERRONEOUS ASSIGNMENTS

1. The undersigned is the attorney of record for the above Registrant and is authorized to file this Declaration on behalf of Registrant.
2. The Post Registration Office Action alleges the assignments of Reel 2153/Frame 0493 and Reel 2155/Frame 0365 constitute "two breaks in the chain of title" for the above Registration.
3. However, Registrant did not assign any rights whatsoever regarding the above Registration to the purported assignor (Moon Crescent Studios, Inc.) listed in Reel 2153/Frame 0493 or Reel 2155/Frame 0365.
4. Thus, there is no break in title since there is no assignment from the original Registrant to the purported assignor (Moon Crescent Studios, Inc.). Thus, any purported assignment by Moon Crescent Studios, Inc. is a nullity since there is no chain of title into that assignor.
5. What happened here is fairly clear: Moon Crescent, Inc. filed a series of six applications to register PC AND THE WEB (Ser. Nos. 76021519 through 76021524, now abandoned). The assignments in question transposed the numbers 2 and 1 in each of the six serial numbers. Thus, Ser. No. 70621524 became 706012524, which is the serial


number associated with the above registration. Apparently, the USPTO's automated system then converted each of these erroneous application numbers into registration numbers, where possible. See the enclosed certified copies of those two assignments.

6. Since the erroneous assignments are not in the chain of title they cannot affect ownership and are therefore irrelevant.
