RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (this “Release”) is given on this 25 day of January 2007 by Credit Suisse, formerly known as Credit Suisse First Boston, as First Lien Administrative Agent and First Lien Collateral Agent (the “Agent”) for the banks and other financial institutions (the “Lenders”) from time to time party to the First Lien Credit Agreement, dated as of April 28, 2004, among Meridian Automotive Systems, Inc. (the “Borrower”), the Lenders and the Agent (as amended, supplemented or otherwise modified from time to time, the “First Lien Credit Agreement”), to Meridian Automotive Systems – Composites Operations, Inc., formerly known as Cambridge Acquisition Corp. and successor-in-interest to Cambridge Industries, Inc., a Delaware corporation (the “Grantor”), as follows:

WHEREAS, in connection with the First Lien Credit Agreement, the Borrower, the Grantor and the other parties thereto executed and delivered a First Lien Guarantee and Collateral Agreement, dated as of April 28, 2004, in favor of the Agent (together with all amendments and modifications, if any, from time to time thereafter made thereto, the “First Lien Guarantee and Collateral Agreement”);

WHEREAS, pursuant to said First Lien Guarantee and Collateral Agreement, the Grantor pledged, assigned and transferred to the Agent, and granted to the Agent, for the ratable benefit of the Lenders, a security interest in the Grantor’s trademarks listed on the attached Schedule A (the “Trademarks”);

WHEREAS, said security interest was recorded in the United States Patent & Trademark Office on May 26, 2004 at reel/frame 2861/0472; and

WHEREAS, the Agent now desires to terminate and release the entirety of its security interest in the Trademarks.

NOW, THEREFORE, for good and valuable consideration, sufficiency of which is hereby acknowledged, and upon the terms set forth in this Release, the Agent hereby terminates, releases and discharges its security interest in the Trademarks, and any right, title or interest of the Agent in such Trademarks shall hereby cease and become void.
