Yak Pak, Inc., a Delaware corporation, hereby certifies that:

**FIRST:** That the names of the constituent corporations are Yak Pak, Inc., a Delaware corporation (hereinafter "Yak Pak"), and Yak Imports, Inc., a Connecticut corporation (hereinafter "Yak Imports"), and that the surviving corporation is Yak Pak.

**SECOND:** An Agreement and Plan of Merger has been approved, adopted, certified, executed and acknowledged by each of Yak Imports and Yak Pak in accordance with the provisions of subsection (c) of Section 252 of the General Corporation Law of the State of Delaware. The Plan as so approved and adopted is on file at the principal office of Yak Pak, which is located at 900 Broadway, New York, New York 10003.

**THIRD:** That the effective time of the merger shall be September 18, 2006, if this Certificate is filed with the Secretary of the State prior to such time or upon the filing of this Certificate with the Secretary of the State if it is filed after such time.

**FOURTH:** The Certificate of Incorporation of Yak Pak, Inc., a Delaware corporation, as now in force and effect, shall continue to be the Certificate of Incorporation of the surviving corporation until such time as it may be amended and changed pursuant to the provisions of the General Corporation Law of the State of Delaware.

**FIFTH:** The Plan has been approved by the shareholders of Yak Imports and Yak Pak alike, and such shareholders so approved the Plan by unanimous written consent.




