

TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (the Trademark Assignment) is made and entered into as of the 30th day of April, 2004,

BETWEEN: Connors Bros., Limited, a corporation existing under the laws of the Province of New Brunswick (hereinafter the "Assignor")

-and-

Clover Leaf Seafoods, L.P., a limited partnership existing under the laws of the Province of Ontario, by its general partner Connors CL GP Limited (hereinafter the "Assignee").

WHEREAS, pursuant to that certain Transaction Agreement and Disclosure Schedules dated as of February 10, 2004, Assignor's business in Canada, including certain Intellectual Property Rights (as defined in the Transaction Agreement) has been contributed to Assignee; and

WHEREAS, among the Intellectual Property Rights to be assigned to Assignee are certain foreign trademarks owned by Assignor, and any trademark registrations and applications therefore or with respect thereto, all as set forth in Schedule 4.11 to the Disclosure Schedules, a copy of which is annexed hereto as Exhibit A.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Assignor is the owner of certain foreign trademarks and service marks, including certain registrations therefore or applications with respect thereto, all as set forth on Exhibit A annexed hereto (referred to collectively as the "Foreign Trademarks").
2. Assignor does hereby sell, assign and transfer unto the Assignee, its successors and assigns, all of its right, title and interest in and to the said Foreign Trademarks, together with any and all goodwill of the Assignor's business associated with or symbolized by the Foreign Trademarks, and all of Assignor's rights, if any, to sue for or make claims with respect to any past, present or future infringement of the Foreign Trademarks.
3. This Trademark Assignment is subject to all licenses and other rights in and to the Foreign Trademarks previously granted to any third person, including without limitation those listed on Schedule 4.11 to the Disclosure Schedules.
4. Assignor further covenants and agrees to execute and deliver, without further consideration, any instruments or other documents, and to cooperate with Assignee, as may reasonably be required by Assignee, to effectuate the full purpose and

intent of this Trademark Assignment, including, without limitation, delivering or providing to Assignee such other instruments or documents as may be necessary to effectuate the recordation of this Trademark Assignment with the appropriate intellectual property office.

5. This Trademark Assignment shall be governed by and construed in accordance with the laws of the State of New York without regard to the conflicts of law principles thereof.

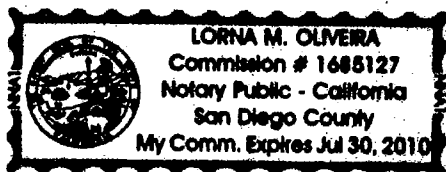
