TRADEMARK ASSIGNMENT

This Trademark Assignment is made as of June 6, 2006 (the "Effective Date") from CP Media, Inc., a Massachusetts corporation with its principal office located at One Herald Square, Boston, MA 02118 ("Assignor") to GateHouse Media Massachusetts I, Inc., a Delaware corporation with its principal office at 350 WillowBrook Office Park, Fairport, NY 14450 ("Assignee").

RECITALS

WHEREAS, Assignor and Assignee are parties to a certain Asset Purchase Agreement dated May 5, 2006 (the "Purchase Agreement"), under which Assignor agreed to sell, and Assignee agreed to purchase, substantially all of the assets and the newspaper business (the "Business") of Assignor;

WHEREAS, included among the assets to be purchased by Assignee are all the federal, state and common law trademarks and service marks used in the Business, and all the goodwill associated therewith (collectively the "Marks"), including federal trademark applications and registrations listed on EXHIBIT A attached hereto, and the state trademark applications and registrations listed on EXHIBIT B attached hereto; and

WHEREAS, Assignee is this date purchasing the Business as a going concern subject to and in accordance with the terms of the Purchase Agreement.

AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by Assignor, Assignor hereby agrees as follows:

1. All terms not otherwise defined in this Assignment shall have the same respective meanings ascribed to them in the Purchase Agreement.
2. Assignor hereby sells, assigns and transfers to Assignee, its successors and assigns the entire right, title, and interest in and to the Marks, together with the registrations of and registrations for the Marks, and the goodwill of the Business symbolized by and associated with said Marks and registrations thereof, including, but not limited to, the following:
 - (a) the right to sue and recover for, and the right to profits or damages due or accrued arising out of or in connection with, any and all past, present or future infringements or dilution of or damage or injury to the Marks or the registrations thereof or such associated goodwill; and
 - (b) the right to prosecute and secure registrations therein in Assignee's own name and to secure renewals of the registrations of the Marks.
3. In the case of any conflict in the terms of this Trademark Assignment and the Purchase Agreement, the terms of the Purchase Agreement shall control.

IN WITNESS WHEREOF, the Assignor has caused this Assignment to be executed as a sealed instrument as of the date written below by its officer thereunto duly authorized.
