**RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE, dated as of January 30, 2007, is made by GENERAL ELECTRIC CAPITAL CORPORATION, (“GECC”), as Administrative Agent (the “Administrative Agent”), pursuant to the termination of the Credit Agreement, dated as of August 16, 2006, as amended by and among ClientLogic Corporation, ClientLogic Operating Corporation, and Service Zone, Inc. (collectively, the “Grantors”), the other Credit Parties signatory thereto from time to time, the Lenders and the L/C Issuers from time to time party thereto and GE Capital, as Administrative Agent for the Lenders and the L/C Issuers.

WITNESSETH

WHEREAS, pursuant to the Trademark Security Agreement (the “Security Agreement”) by and among the Grantors and the Administrative Agent, dated August 16, 2006 and recorded with the U.S. Patent and Trademark Office on August 18, 2006 at Reel/Frame No. 3373/0042, Grantors granted the Administrative Agent a lien on and security interest in and to all of its right, title and interest in, to and under all trademarks, all goodwill associated with such trademarks, and proceeds of any and all of the foregoing;

WHEREAS, the Administrative Agent acknowledges full payment, complete performance and satisfaction of all obligations pursuant to the Agreement secured by the Security Agreement have been made;

WHEREAS, the Grantors have requested that the Administrative Agent release its security interest in the Trademark Collateral, as defined in the Security Agreement in connection with the termination of the Agreement, and the Security Agreement (the “Released Collateral”).

NOW, THEREFORE, in consideration of the foregoing, the Administrative Agent hereby RELEASES, without recourse, representation, warranty, or other assurance of any kind, all of its security interest in the Trademark Collateral, listed on Schedule I attached hereto and incorporated herein by reference, and any other collateral described in the Security Agreement.

The Administrative Agent agrees to provide the Grantors, at the Grantors’ joint and several sole expense, with any information and additional authorization necessary to effect the release of its security interest in the Released Collateral.

IN WITNESS WHEREOF, the Administrative Agent has executed this Release as of the date first set forth above.
