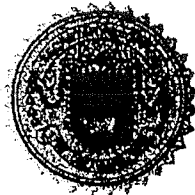

Pursuant to Title 8, Section 252 of the Delaware General Corporation Law, the undersigned corporation executed the following Certificate of Merger:

FIRST: The name of the surviving corporation is StayOnline, Inc., a Delaware corporation and the name of the corporation being merged into this surviving corporation is Stayonline, Incorporated, a Georgia corporation.

SECOND: The Agreement and Plan of Reorganization (the "Agreement"), dated as of July 29, 2004, by and among STAYONLINE, INCORPORATED, a Georgia corporation, STAYONLINE, INC., a Delaware corporation, and HOTEL ONLINE 1, LTD., a Texas general partnership, and related Plan of Merger between STAYONLINE, INCORPORATED and STAYONLINE, INC. has been approved, adopted, certified, executed and acknowledged by each of the constituent entities in accordance with the requirements of Title 8, Section 252 of the General Corporation Law of the State of Delaware and relevant provisions of the Georgia Business Corporation Code. The shareholders of STAYONLINE, INCORPORATED and STAYONLINE, INC. have approved the merger.

THIRD: The name of the surviving corporation is StayOnline, Inc., a Delaware corporation.

FOURTH: The Certificate of Incorporation of the surviving corporation shall be its Certificate of Incorporation.
