3. The name of the Limited Liability Company immediately prior to the filing of this Certificate is "FinanSure, LLC."

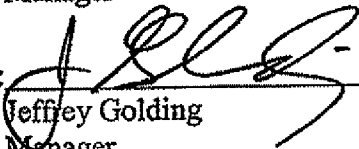
4. The name of the Corporation as set forth in the Certificate of Incorporation is "FinanSure, Inc."
