ASSIGNMENT OF TRADEMARKS

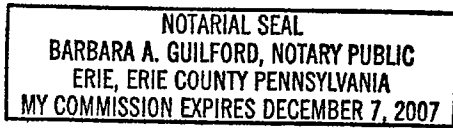
