Release of Lien on Trademarks


This Release of Lien on Trademarks (the "Release"), dated as of January, ~~20~~ 2007 is made by Societe Generale, a French corporation, as agent (the "Agent") for the financial institutions party to the Senior Secured Credit Agreement dated as of July 31, 2002 among Interstate Operating Company, L.P, the Agent and the other parties thereto, in favor of Bridgestreet Corporate Housing Worldwide, Inc., a Delaware corporation (the "Grantor").

WHEREAS, Grantor entered into a Security Agreement, dated as of July 31, 2002 and recorded in the United States Patent and Trademark Office as of September 31, 2002 at Reel 2590, Frame 0196, pursuant to which Grantor granted to the Agent a security interest in and lien on all right, title and interest of the Grantor in certain trademarks, including the trademark registrations and applications set forth on Schedule A attached hereto (the "Released Trademarks"), in addition to other trademark registrations and applications which are not a subject of this Release (the "Unreleased Trademarks"), to secure the performance of certain obligations (the "Obligations");

WHEREAS, the Released Trademarks are no longer included in the collateral securing the performance of the Obligations, and Grantors have requested that the Agent release any and all interest it may have in the Released Trademarks, and the Agent has agreed to do so.


NOW, THEREFORE, in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby release, relinquish and discharge its security interest in, to and under the Released Trademarks, but does not release, relinquish and discharge its security interest in, to and under any of the Unreleased Trademarks.
