Pursuant to Title 8, Section 252 of the Delaware General Corporation Law, the undersigned corporation executed the following Certificate of Merger:

**FIRST:** The name of the surviving corporation is CAI International, Inc., a Delaware corporation ("CAI-Delaware"), and the name of the corporation being merged into this surviving corporation is Container Applications International, Inc., a Nevada corporation ("CAI-Nevada").

**FIFTH:** The authorized capital stock of CAI-Nevada is 220,000 shares of capital stock, \$.0001 par value per share.


**SIXTH:** The merger is to become effective on February 2, 2007.
