**RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

NOW, THEREFORE, U.S. Bank, without recourse, representation or warranty and at Hard Rock's sole cost and expense, hereby RELEASES all of its right, title and interest in and to the security interest granted to U.S. Bank pursuant to the Security Interest in each of the trademarks set forth in Schedule A, attached hereto and incorporated herein by reference and any other collateral described in the Security Agreement.

U.S. Bank agrees to provide Hard Rock with any information and additional authorization necessary to effect the release of U.S. Bank's security interest in the Released Trademark Collateral.

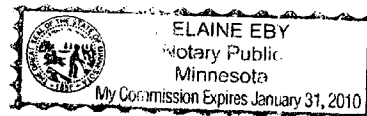


