Further, Assignor agrees that, upon request and without further compensation, but at no expense to Assignor, Assignor and its legal representatives and assigns will do all lawful acts, including the execution of papers and the giving of testimony, that may be necessary or desirable for obtaining, maintaining, renewing or enforcing said Marks, and for perfecting, recording or maintaining the title of Assignee, its successors and assigns, to said Marks.


Assignor authorizes and requests the Commissioner Trademarks to issue any registrations or renewals granted for said Marks, to Assignee, its successors and assigns, as the assignee of the entire interest in said Marks.

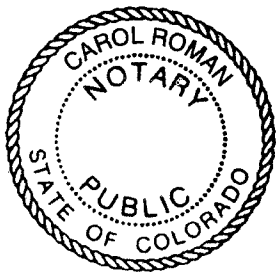
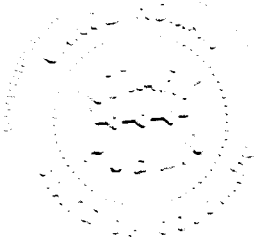
