**TRADEMARK SECURITY AGREEMENT TERMINATION AND
RELEASE OF SECURITY INTEREST**

This instrument is executed effective as of the 30th day of January, 2007 by Bank Of America, N.A., having a principal business address of 231 South LaSalle Street, Mail Code: IL 1-231-08-30, Chicago, Illinois 60697, as Administrative Agent (the "Administrative Agent") for the several banks and other financial institutions (the "Lenders") which are parties to the Credit Agreement (hereinafter defined).

WHEREAS, ATC Drivetrain, Inc., a Delaware corporation formerly known as Proformance Powertrain Products, Inc. (the "Grantor"), having an address at 1400 Opus Place, Suite 600, Downers Grove, Illinois 60515, and the Administrative Agent executed a Grant of Security Interest in Trademark Rights dated as of March 21, 2006 ("**Grant Of Security Interest**"), under which Grant Of Security Interest the Grantor granted to the Administrative Agent a continuing security interest in, among other things, all of the Grantor's right, title, and interest in and to the U.S. Trademark registration (collectively, the "**Trademark**") listed in Exhibit A attached hereto, to secure payment and performance in full of certain obligations of the Grantor and its affiliates under a Guaranty and Collateral Agreement dated as of March 21, 2006 made by the Grantor and such affiliates in favor of Administrative Agent for the ratable benefit of the Lenders under that certain Credit Agreement dated as of March 21, 2006 among the Grantor's parent company Aftermarket Technology Corp., Administrative Agent and such Lenders (the "**Credit Agreement**").


WHEREAS, the Administrative Agent recorded the Grant Of Security Interest with the United States Patent and Trademark Office, Assignment Branch, on March 24, 2006, which Grant Of Security Interest was recorded at Reel /Frame 3275 / 0942; and

WHEREAS, the Administrative Agent desires to terminate and release its security interest in the Trademark.

NOW, THEREFORE, the Administrative Agent by these presents does hereby release the continuing security interest in all trademark registrations and applications at any time owned by Grantor, relating to the Trademark described on Exhibit A attached hereto, and the goodwill represented thereby, and including, without limitation, all renewals thereof, all proceeds thereof (including, but not limited to, all license royalties, and proceeds of infringement lawsuits), and the right to sue for past, present, and future infringements.
