RELEASE OF SECURITY AGREEMENT

THIS RELEASE dated as of **January 29, 2007** (this "Release") is made by U.S. Bancorp Republic Commercial Finance, Inc. f/k/a Republic Acceptance Corporation, acting in its capacity as secured party (in such capacity, the "Secured Party") under that certain Security Agreement, recorded as of **May 12, 1993** and recorded in the records of the United States Patent and Trademark Office (as amended, supplemented or modified and in effect from time to time, the "Security Agreement"), among **T.D.J. W I T N E S S E T H:
