## DECLARATION OF MARSHALL J. NELSON

I, Marshall J. Nelson, hereby declare:

1. I am an attorney for Confirma, Inc. and am authorized to make this declaration on its behalf. I am competent to testify and have personal knowledge of the matters addressed herein.
2. The attached record from the Assignment Division of the U.S. Patent and Trademark Office (PTO) describing details of a Termination Agreement recorded at Reel/Frame #2763/0633 includes as item 7 a registration for SURELOC, Serial # 78/417993, Reg. # 2966958, filed May 13, 2004 and registered July 12, 2005, which is owned by Confirma, Inc.
3. No interest in the mark SURELOC or its registration has ever been conveyed to either the Assignor or Assignee shown in the attached record.
4. The date of recordation shown in the record, December 15, 2003, predates the application filing date for SURELOC, May 13, 2004, by five months. It is therefore impossible for the mark SURELOC or its registration to have been included in the recorded document, and its inclusion in this record is clearly erroneous on its face and should be corrected.

I further declare that all statements made herein of my own knowledge are true and that all statements made on information and belief are believed to be true; and further that these statements are made with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code, and that such willful false statements may jeopardize the validity of the registration in question.
