DECLARATION OF MARSHALL J. NELSON

I, Marshall J. Nelson, hereby declare:


1. I am an attorney for Confirma, Inc. and am authorized to make this declaration on its behalf. I am competent to testify and have personal knowledge of the matters addressed herein.

2. The attached record from the Assignment Division of the U.S. Patent and Trademark Office (PTO) describes details of a Security Interest recorded at Reel/Frame #3258/0470 purportedly executed by Confirma, Inc. as the Assignor of six registrations that are not owned, and never have been owned, by Confirma, Inc. and were never assigned by Confirma, Inc. to the purported Assignee Comerica Bank. The record is in error.

3. Items 1-3 are registrations for AUTOCONFS owned by Automated Confirmation Service Limited, a UK company, according to records of the PTO. Items 4-5 are registrations for CONFIRMATION-PLUS owned by Confirmation Plus LLC, an Arizona company, according to records of the PTO. Item 6 is a registration for CONFIRMANT, owned by Confirmant Limited, a UK company, according to records of the PTO. Confirma, Inc. is not related in any way to any of these companies.

I further declare that all statements made herein of my own knowledge are true and that all statements made on information and belief are believed to be true; and further that these statements are made with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code, and that such willful false statements may jeopardize the validity of the registration in question.
