Vaisala Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation"), does hereby certify:

FIRST: That the Corporation was incorporated on the 29th day of May, 1981, pursuant to the General Corporation Law of the State of Delaware.

SECOND: That the Corporation owns all of the outstanding shares of each class of the stock of Vaisala-GAI Inc., a corporation incorporated on the 21st day of February, 1995 pursuant to the General Corporation Law of the State of Delaware.

THIRD: That the Board of Directors of the Corporation, acting by written consent dated the ___ day of December, 2002, duly adopted the following resolutions:

RESOLVED: That, pursuant to Section 253 of the Delaware General Corporation Law, the Corporation is hereby authorized to merge Vaisala-GAI Inc., a Delaware corporation and wholly owned subsidiary of the Corporation ("Vaisala-GAI"), with and into the Corporation;

RESOLVED: That the President, Chief Financial Officer, Secretary and any Assistant Secretary of the Corporation be, and each of them acting singly hereby is, authorized to execute a Certificate of Ownership and Merger with respect to the merger of Vaisala-GAI with and into the Corporation, to cause the same to be filed with the Secretary of State of Delaware, and to take all such other actions and to execute all such other instruments and agreements as they or any of them may deem appropriate to effect such merger; and

RESOLVED: That the merger of Vaisala-GAI with and into the Corporation shall be effective January 1, 2003.
