RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, The Doe Run Resources Corporation, a New York corporation ("Debtor"), with its principal place of business at 21801 Park 270 Drive, Suite 300, St. Louis, Missouri 63146 granted a security interest in and lien upon certain trademarks and related rights to U.S. Bank National Association (successor to State Street Bank and Trust Company), as Trustee and Collateral Agent ("Secured Party") as set forth in the Security Agreement, dated as of October 29, 2002, among Debtor, certain affiliates of Debtor and Secured Party (the "Security Agreement");

2. agrees that any power of attorney or similar rights granted by Debtor to Secured Party pursuant to or in connection with the Security Agreement is terminated; and
3. authorizes and requests that the Patent and Trademark Office note and record the existence of the release hereby given.

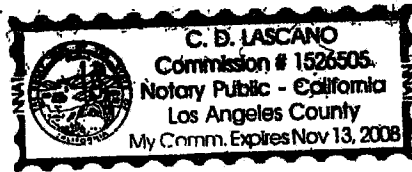
