RELEASE OF SECURITY INTEREST
IN TRADEMARKS

AZTAR CORPORATION, a Delaware corporation, ADAMAR OF NEW JERSEY, a New Jersey corporation, RAMADA EXPRESS, INC., a Nevada corporation, and HOTEL RAMADA OF NEVADA, a Nevada corporation (collectively, "Grantor"), whose address is 2390 E.
