I hereby authorize and request the U.S. Patent and Trademark Office to register this assignment, and issue all registrations based on said marks, and renewals and extensions of the REGISTRATIONS to said ASSIGNEE, its successors and assigns.

I hereby consent that a copy of this assignment shall be deemed a full and legal and formal equivalent of any assignment, consent to file or like document which may be required in any country for any purpose.
