TRADEMARK RELEASE, effective as of this 31st day of January, 2007, given by Deutsche Bank Trust Company Americas, as Collateral Agent ("Agent") with principal offices at 60 Wall Street New York, New York 10005, to Sturm Foods, Inc., a Wisconsin corporation ("Grantor") with principal offices at 215 Center Street, Manawa, WI 54949-0287, as follows:
