TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS ("Agreement"), dated as of February 9, 2007 is given by Capital Business Credit LLC (f/k/a Capital Factors LLC) ("Capital").


